The maximum volume of electricity sales for a trading day d on the BC, DAM, IDM and electricity export by market participants is determined in % of the total volume of electricity issued per d-3 of this market participant according to the available commercial accounting data in the market management system at the time of calculation

Order of the Ministry of Energy of Ukraine № 187 dated on 26.05.2022

«On stabilization of the electricity market»:

- market participants shall purchase electric energy on the day-ahead market in the volume of at least 10% of consumers` consumption within 10-day period
- In case of electricity non-purchase in the mentioned amount, such market participant is obliged to buy the relevant volumes
 of electricity on the day-ahead market on the next 10-day period, otherwise such market participant acquires the status of
 "Default"

DAM in the IPS in MAY 2022

Emphases:

- ✓ The DAM BASE index in the IPS has not changed in May 2022
- ✓ Decrease in demand from market participants by -31,8% (-239,3 GWh, demand in May amounted to 512,8 GWh).
- ✓ Decrease in supply by -55,3% (- 3 470,3 GWh, supply in May amounted to 2 804,2 GWh) from producers without suppliers and traders.
- ✓ There is an available unaccepted volume on the DAM of 29,8 MWh for 06.05.2022
- ✓ The BASE index on European markets was higher than the IPS base load price index




DAM demand and supply in the IPS




IDM in the IPS in MAY 2022

Emphases:

- ✓ Increase of the weighted average price on the IDM in the IPS by +8,1% (UAH 207,48)
- ✓ Decrease in demand by -20,6% (-4,1 GWh, demand in May amounted to 15,9 GWh) through reduced purchases from suppliers by -47,1%, DSOs by -83,5%, traders by -100%, while increasing producer`s purchase by +281,4%
- ✓ Increase in supply by +17,6% (171,6 GWh, supply in May amounted to 1 145,4 GWh) from market participants
- ✓ IDM weighted average prices in the IPS are lower than those of European countries



IDM demand and supply in the IPS







Price indices of the European countries

In May 2022, the DAM average prices in the IPS of Ukraine were lower than the corresponding indicators of neighboring countries: the base-load price indices in the IPS were lower from -48,6% to -64,8%.
