DAM RESULTS in the IPS of UKRAINE

Legislative changes in the electricity market, extended in August :

Law of Ukraine dated on 29.07.2022 № 2479-IX

«On the features of regulating relations on the natural gas market and in the heat supply during martial law, and their subsequent restoration»

the electricity producers (except those which have a "green" tariff, and producers that have acquired the right to support by the results of the auction) will sell electricity under the bilateral contracts exclusively through electronic auctions temporarily, until April 1, 2023.

NEURC's Resolution № 332 dated on 25.02.2022 (with changes from 27.02.2022):

- restrictions on the minimum declared prices on the DAM in the IPS :
2 646,25 UAH/MWh (net of VAT) - for hours of maximum load (from 07:00 to 23:00)
1 378,97 UAH/MWh (net of VAT) - for hours of minimum load (from 00:00 to 07:00 and from 23:00 to 24:00)
- Price Caps on the DAM in the IPS :
4 000 UAH/MWh (net of VAT) - for hours of maximum load (from 07:00 to 23:00)
2 000 UAH/MWh (net of VAT) - for hours of minimum load (from 00:00 to 07:00 and from 23:00 do 24:00)

Order of the Ministry of Energy of Ukraine dated on 28.02.2022 №94

«On stabilization of the electricity market operating»

The NPC UKRENERGO determines the DAM maximum sales volume in the amount of zero MWh (0 MWh) for market participants that are electricity suppliers and/or traders, temporarily, from March 2, 2022, and for the period of martial law in Ukraine.


Emphases:

- ✓ **The DAM BASE index in the IPS increased by +12,1% in August (+ UAH 309,37)**
- ✓ **Increase in demand by +19,3% (+130,7 GWh, demand amounted to 808,2 GWh in August) from electricity producers and suppliers**
- ✓ **Decrease in supply by -30,6% (-678,4 GWh, supply in August amounted to 1 539,7 GWh) from producers**
- ✓ **Decrease in unaccepted volume by -50% (-751,1 GWh, unaccepted volume was 751,3 GWh in August)**
- ✓ **The BASE index on European markets was higher than the IPS base load price index**




Legislative changes in the electricity market, extended in August :

NEURC's Resolution № 332 dated on 25.02.2022 (with changes from 31.05.2022):

the DAM/IDM participants of the trading zone «the IPS of Ukraine» should indicate the price of electricity in their IDM orders at least 102% of the IDM price, defined by the MO for each settlement period of the respective delivery day


Emphases:

- ✓ *Increase in the IDM weighted average price in the IPS by +10,2% (+UAH 278,20)*
- ✓ *Increase in demand by +11,1% (+5,4 GWh, demand amounted to 54,4 GWh in August) from producers and suppliers, declared purchase volumes from traders were minor and significantly reduced*
- ✓ *Decrease in supply by -25% (-250,9 GWh, supply amounted to 752,9 GWh in August) from all market participants*
- ✓ *The IDM weighted average prices in the IPS are lower than those in the European countries*





IDM demand and supply in the IPS




IDM in the IPS

The spread is calculated at the average prices of the respective days and hours. In the absence of trading at certain hours on the IDM, the relevant DAM data were not taken into account in the calculation.

Price indices of the European countries

The DAM average prices in the IPS of Ukraine were lower than the corresponding indicators of neighboring countries in August 2022 : the base-load price indices in the IPS were lower from -71,7% to -84,4%.

Price indices of the European countries

European DAM prices increased significantly in August 2022 compared to July 2022. The increase in the countries bordering Ukraine ranged from +31,3% in Poland to +49,1% in Czech Republic.
